Commons Committee Hears Protest; Against Action Ontario Railway Franchiaa Holders.

In rhe Railway Committee this morning the Pontiac Central Railway Company. which at present holds a charter from the Quebec Legislature to build from Bryson in the county .of Pontiao north and to a unction with the Trans-continental Railway, asked for power to extend its proposed line southward to Brockville and northward to Hudson Bay, and in view of this proposed extension into a sister province asked that the work be declared a work for the general advantage of Canada. Messrs. Sproule. M.P., and Lennox, M. P., took the ground that the provincial charter ought not to be taken over without due consideration of its provisions.

Under its charter the company is entitled to issue land grant bonds on any lands that it may hold and to erect hotels, warehouses, elevators, mills. manufacturing establishments, etc., at the request -of the Minister of Railways, the bill was held for further consideration..

The Railway Committee of the House of Commons on Wednesday last passed the bill of the Pontiac Central railway, which authorizes the construction of a line of railway from some point near Bryson or Portage du Fort to the town of Brockville, passing thorugh the counties of Renfrew, Lanark and Leeds, and also running in a northerly direction (whether running up the valley of the Coulonge or Black River, does not appear from notice of application published some time ago) along the valley of the Nottaway River to the East Main River, in thisprovince. The project outlined above seems to be of a rather mysterious character, as the promoters - whoever they are - have said very little about it, and, so far as we know, have not been soliciting any bonuses from the municipalities through which they intimate it is to run. Perhaps this will form a later stage of development. In the meantime, people (especially along the southern end of the route) will be interested to know just what the railway means, and what is the extent and character of the business it has in view. The men behind the scheme should let the public into the secret.
