Specification and Description and Contract and Agreement attached.
- PC 1894-1165 16/04/1894 Application has been made by the M&O (operated by the CPR) for an extension of the time for completion of their subsidized railway from Vaudreuil towards Hawkesbury. The unpaid balance of subsidy was revoked by 54-55 Vic. chap 8 and the time for completion having been extended to 1 July 1894 by Order in Council of 22 July 1893. Council agrees to further extend the time for completion to 1 August 1896.
- PC 1896-3047 14/09/1896 Approves plans and profiles of a revised location of the first 15 miles from Rigaud westerly on the Montreal and Ottawa Railway.
- PC 1896-3495 21/10/1896 Approves entry into contract for seven miles remaining unbuilt from Vaudreuil towards Hawkesbury and for the 30 miles westward from the said seven mile section. Approves location shown by the plans and profiles from boundary of East Hawkesbury township (about 14.5 miles from Rigaud to a point near the Nation River about 33 3/4 miles from Rigaud.
- PC 1897-651 20/03/1897 Chief Engineer reported on 17 Mar 1897 on an inspection of the Montreal & Ottawa Ry. from the 23rd to the 33rd mile from Vaudreuil which has been completed according to contract. Total subsidy applicable for the 33 miles is \$105,000 of which \$73,600 has been paid. The Minister is authorized to pay the balance of \$32,000.
- PC 1897-2968 26/10/1897 Chief Engineer of Department of Railways reported on 23 Oct 1897 that an inspection of the M&O from the 33rd to the 45 1/2 mile from Vaudreuil showed that the section had been built according to contract. Minister is authorized to pay a further \$40,000.
